



**VILLAGE OF AKRON**  
**PARK COMMITTEE MEETING AND ORDINANCES**

**JULY 8<sup>TH</sup> 2025**

The Park Committee meeting was called to order at 5:57 p.m. followed by the Pledge of Allegiance and roll call.

**Council Members' Present:** R. Huizar, T. Nusz, D. Meyer,

**Employees Present:** C. Wilson, S. Bills

The ordinances that were discussed were as follows: Fireworks, Open Burn, Farm Animals, Fiscal Policies, Street Openings and Obstructions, Water, Weed, Building Code, Dog, Parking, State of Construction Act, and Notice of Ordinance Adoption.

Regarding the Fireworks Ordinance, it was to be added that no person shall ignite or discharge fireworks under the age of 18. The time of igniting fireworks was changed to end at 11 p.m. and the word marijuana was added while under the influence.

Regarding the Open Burn Ordinance Section 3 was changed by eliminating trees, brush, branches with leaves and smaller than 2" in diameter, grass clippings and leaves. In Section 4 the words OR A BONFIRE is to be eliminated. Section 8B the word lining is to be replaced by living.

Regarding Farm Animals Ordinance it needs to be entirely retyped eliminating Cows and Horses along with the disposal of animal remains.

Regarding Fiscal Policies it needs to be completely retyped with the elimination of several things including Section II, G, H, I and Section III H. There were several spelling errors that also need correcting. Regarding the Street Opening and Obstruction Ordinance, all was good with that it just needed a new sign sheet on the back with the date.

Regarding the Water Ordinance in Section 4, Billing the words on the 15<sup>th</sup> were replacing the 10 days after the date of such a bill. In Section 5 the words the 15<sup>th</sup> of the month will be replaced within 10 days from the date of such a bill. And the 10% penalty rate will change to a flat rate fee of \$4.00. Section 6, the 30 days' notice of water turn off will be 7 days and there will be a \$30.00 turn on fee assessed if your water is turned off. The council decided to eliminate the Section 11 Operation and Maintenance Fund. There were many spelling errors to correct as well.

Regarding the Weed Ordinance, the months were changed to May through October for all noxious weeds in section 4. The Month was changed again to May through October and one week notice will be given before entering property to cut and destroy such weeds.

Regarding Building Code Ordinance all was good with it except for spelling errors to be corrected and the signature page and date to be changed.

Regarding the Dog Ordinance the council decided to add to Section 5 the owner is responsible for immediately removing and disposing of dog feces when on public or private property not owned or possessed by them. The number of dogs owned will be 3 dogs in a single-family dwelling. All dogs must be licensed will be added to Section 2-Restrictions.

Regarding the Parking Ordinance it was good just needing retyped and signature and date page on back. Regarding the State of Construction Code Act it was good and needs a new signature and date sheet on the back.

Regarding the Notice of Ordinance Adoption Ordinance, it was good but needed retyping because of many spelling errors.

Park Committee talked about the Firemen wanting to help redo the ball diamond fence and the dugout by asking local farmers and businesses for donations in return they would have a banner attached to the fence with their business displayed. R Huizar asked if anyone had any ideas for a fundraiser to help. It was also discussed about the pavilion to get new windows and a better floor in it. The windows were discussed for the pavilion about possibly Plexiglass or Roll down windows, the cost is expensive. Shane was asked to get a quote on the cost of leveling the pavilion floor. Trees were also discussed throughout the park; some are dangerous and in fear of falling into buildings or someone getting hurt. Shane was asked to get a couple quotes for tree removal. Shane said that he did remove some of the posts on Ringle Rd driveway side and it looks so much nicer, council told Shane to remove the remaining posts. Near the Memorial Shane asked if he could remove some of the overgrown rose bushes there. The council said that he could trim them back and carefully see if they could be removable. C. Wilson will check into a couple of grants for the windows and cameras for the park.
